During the month of August 2009, Sector 112 experienced an overall increase of major crimes (violent and property) by 7% as compared to August of 2008. Sector 112 Officers and Supervisors identified neighborhoods targeted by these crimes and implemented an attack plan to curb this trend in September.

#### Violent Crime:

- There were 6 robberies of individuals in Sector 112 during August 2009. Although one robbery is too many, this number is the same as reported in 2008.
- All 6 robberies involved only one suspect.
- 2 of the 6 robberies involved gun .
- There were also 4 aggravated assaults in Sector 112. Two have been cleared by arrest. 2 assaults involved bar fights.

#### Property Crime:

- In August, Sector 112 was hammered by theft from buildings, a very difficult crime to prevent. Theft from vehicles was also up, 11 cars were broken into during August 2009. Areas included the Bottom, Oak Grove and Belle Isle parking lots. Please lock your valuables
- In August motor vehicle thefts were down by 3, burglary's remained the same as last year, and all other larceny's were down by 2. Overall a very good property crimes month, only up 3 crimes over last year.
