During the month of July, overall crime is down four percent in sector 411 compared to July 2008. Property crimes continue to decrease while violent crimes are increasing.

Violent Crime:

Robberies of individuals have increased during the last few weeks. We've experienced an increase of robberies in the Gilpin Community and along the 1200-1400 blocks of Brookland Park Blvd.

If you find yourself being robbed try and follow these steps:

- Stay calm.
- Do not resist!
- Get a good look at the robber so you can describe him later. Take note of any particular features such as scars, marks or tattoos.
- Take a close look at the get away car. Take note of the type of car, color, tag number and direction of travel
- Call 911 as soon as it's safe.

As summer draws to an end, many families will be enjoying vacation away from home. Many community members are not aware of our Police Department's Vacation House Watch program. While you're away, police officers will conduct frequent checks on your home.

To prevent burglaries:

- Keep all doors and windows locked. Use dead-bolt locks on exterior doors.
- Install quality out door lighting around the perimeter of your home. Consider motion sensor lights.
- Cut shrubbery regularly to allow visibility around your home.
- Give the impression someone is always home by installing affordable light timers.
- Get a security survey conducted by a certified Crime Prevention Specialist call 646-4189.
- Implement a Neighborhood Watch Group – Call 646-5334 to join.
